WHEREAS, the People's Television Network, Inc. (PTNI) through its Bids and Awards Committee (BAC) advertised on 7 November 2023 the invitation to bid for the "Supply, Delivery, Installation, Testing, and Commissioning of one (1) unit of 75 KVA Prime Power Silent Type Generator Set including training of personnel for PTV Cordillera Station" under ITB No. 2023-0005 through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 13 November 2023, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, on the deadline of submission and receipt of bid, **5 December 2023 at 10:00 am**, no bids were received;

WHEREAS, pursuant to section 35 of RA 9184 and its revised IRR, the BAC shall declare the bidding a failure when no bids are received;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. Declare the failure of bidding for the "Supply, Delivery, Installation, Testing, and Commissioning of one (1) unit of 75 KVA Prime Power Silent Type Generator Set including training of personnel for PTV Cordillera Station", ITB No. 2023-0005;
2. Conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates. in accordance with the provisions of RA 9184 and its IRR;


