bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

(PTNI)", ITB No. 2023-0004 in accordance with his/her/its Bid.
- The People's Television Network, Inc. agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
