



BAC RESOLUTION NO. 2023-020
DECLARATION OF ANCHOR HUMAN RESOURCES DEVELOPMENT, CORP.
AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER (LCRB)
FOR ITB NO. 2023-0002

WHEREAS, on 30 August 2023, the Bids and Awards Committee (BAC) conducted the pre-procurement conference of the request for the “Provision of Janitorial Services for the People's Television Network, Inc. (PTNI)” where it determines the readiness of the procurement at hand;

WHEREAS, the People's Television Network, Inc. (PTNI) through its BAC advertised the invitation to bid for the said request under ITB No. 2023-0002 through posting in the Philippine Government Electronic Procurement Service (PhilGEPS), Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 15 September 2023, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, three (3) interested bidders bought the bidding documents namely, **(1) CMPT Manpower Services, (2) Anchor Human Resources Development, Corp., and (3) Wizard Manpower and Allied Services;**

WHEREAS, on 27 September 2023 at 10:00 am, the deadline of bid submission, the secretariat received three (3) bids from **(1) CMPT Manpower Services, (2) Anchor Human Resources Development, Corp., and (3) Wizard Manpower and Allied Services;**

WHEREAS, on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bids which was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet

WHEREAS, during the said examination, **Wizard Manpower and Allied Services** were disqualified and declared ineligible for evaluation due to absence of the third page “Annex A” or the “List of Eligibility Documents” of its valid PhilGEPS Registration Certificate (Platinum Membership);

WHEREAS, **CMPT Manpower Services** and **Anchor Human Resources Development, Corp.** both “passed” and rated for evaluation;

WHEREAS, after careful examination, the Technical Working Group (TWG) found that **Anchor Human Resources Development, Corp.** and **CMPT Manpower Services** have both arithmetical errors in their bid offers and were corrected as follows;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. To declare **Anchor Human Resources Development, Corp.** as the Lowest Calculated and Responsive Bidder (SCRB) for the contract on the "Provision of Janitorial Services for the People's Television Network, Inc. (PTNI)", ITB No. 2023-0002;
2. To recommend for the approval of the Head of Procuring Entity (HoPE), the foregoing findings, and the issuance of Notice of Award in favor of the said LCRB
