



**BAC RESOLUTION NO. 2023-030
DECLARATION OF COMPOSITE TECHNOLOGY INC. AS THE SINGLE
CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2023-0006**

WHEREAS, on 21 November 2023, the Bids and Awards Committee (BAC) conducted the pre-procurement conference of the request for the “Supply, Delivery, Installation, Testing, Configuration, and Commissioning of Parts and Services for the Linear Tape Open (LTO) i6000 & i500 of the Technical Operation Center (TOC) Media Asset Management System (MAMS) Archiving Operation for the People's Television Network, Inc. (PTNI)” where it determined the readiness of the procurement at hand;

WHEREAS, the People’s Television Network, Inc. (PTNI) through its BAC advertised the invitation to bid for the said request under ITB No. 2023-0006 through posting on the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 30 November 2023, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only one (1) interested bidder bought the bidding documents namely, **Composite Technology Inc.**;

WHEREAS, on 13 December 2023 at 10:00 am, the deadline of bid submission, the secretariat received one (1) bid from **Composite Technology Inc.** and on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bids which was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the bid of **Composite Technology Inc.** was declared “passed” and rated for evaluation;

WHEREAS, the BAC adopted the observation of the Technical Working Group (TWG) where **Composite Technology Inc.** submitted the Lowest Calculated Bid and provided complete information in their submitted financial component as follows;



(PTNI)", ITB No. 2023-0006 in the amount of two million one hundred thirty-nine thousand and two hundred pesos (PHP 2,139,200.00) inclusive of taxes, duties and other levies
2. Recommend for the approval of the Head of Procuring Entity (HoPE), the foregoing findings, and the issuance of Notice of Award in favor of the said SCRБ


