



**BAC RESOLUTION NO. 2024-003
DECLARATION OF APT SATELLITE COMPANY LIMITED AND NX GENTRI
(NXTRI) INC. (JOINT VENTURE) AS THE SINGLE CALCULATED AND
RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2023-0007**

WHEREAS, on 30 November 2023, the Bids and Awards Committee (BAC) conducted the pre-procurement conference of the request for the “Lease Service Delivery of Eight Megahertz (8Mhz - 4Mhz for Distribution and 4Mhz for Contribution) Standard C-Band Space Segment for the People’s Television Network, Inc. (PTNI)” where it determined the readiness of the procurement at hand;

WHEREAS, the People’s Television Network, Inc. (PTNI) through its BAC advertised the invitation to bid for the said request under ITB No. 2023-0007 through posting in the Philippine Government Electronic Procurement Service (PhilGEPS) and the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 4 January 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only two (2) interested bidders bought the bidding documents namely, (1) **APT Satellite Company Limited And NX Gentri (NXTRI) Inc. (Joint Venture)** and (2) **Praeeo Network Technologies Inc.**;

WHEREAS, on 17 January 2024, the deadline of bid submission, the secretariat received a letter from **Praeeo Network Technologies Inc.** that they will not participate in the bidding;

WHEREAS, on 17 January 2024 at 10:00 am, the deadline of bid submission, the secretariat received one (1) bid from **APT Satellite Company Limited and NX Gentri (NXTRI) Inc. (JV)** and on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bids which was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the bid of **APT Satellite Company Limited and NX Gentri (NXTRI) Inc. (JV)** was declared “passed” and rated for evaluation;

WHEREAS, due to uncertainty with the computation of the Technical Working Group (TWG), the BAC sought the assistance of Finance Personnel to recalculate the bid in which the BAC adopted and found that **APT Satellite Company Limited and NX GENTRI (NXTRI) Inc. (JV)** submitted a correct bid as follows;

WHEREAS, upon verification, validation, and ascertainment of the veracity, authenticity and validity of all eligibility documents in the legal, technical and financial requirements the following has been observed:

1. The bidder stated compliance with the requirement "Transmit and Receive Cross Polarization Isolation, Early Operational Capability (EOC) - ≥ 30.0 decibel (dB)" but the TWG, was unable to verify in the submitted brochure which can only and shall be check during Testing and Commissioning.
2. The bidder also stated compliance with the requirement of providing one (1) pair of satellite phones but the bidder did not submit any brochure of the satellite phone
3. However, the bidder signed an undertaking of a statement of compliance to the technical requirements and specifications, otherwise, if found non-compliance during testing and commissioning, it is understood that the winning bidder shall comply with the required specifications
4. APT SATELLITE COMPANY LTD. AND NX GENTRI (NXTRI) INC. (JOINT VENTURE) was found to be a responsive bidder compliant to all eligibility and documentary requirements.;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it hereby **RESOLVED** to:

1. Adopt the findings of the TWG and declare the bid of **APT Satellite Company Limited and NX GENTRI (NXTRI) Inc. (JV)** as the **Single Calculated and Responsive Bid (SCRB)** for the "**Lease Service Delivery of Eight Megahertz (8Mhz - 4Mhz for Distribution and 4Mhz for Contribution) Standard C-Band Space Segment for the People's**


