**DECLARATION OF SOLID VIDEO CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) FOR ITB NO. 2023-0008**

**WHEREAS**, on **29 December 2023**, the Bids and Awards Committee (BAC) conducted the pre-procurement conference for the request concerning the **“Supply, Delivery, Testing, and Commissioning of Ten (10) Editing Desktop Computer Systems with Non-Linear Editing, Motion Graphics Software, and Network Attached Storage (NAS) for the People’s Television Network, Inc. (PTNI) Manila”** confirming the readiness of the procurement at hand;

**WHEREAS**, the People’s Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid through **Competitive Bidding** for the said request under **ITB No. 2023-0008** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

**WHEREAS**, on **08 January 2024**, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

**WHEREAS**, in response to the said advertisement, only one (1) bidder bought the bidding documents namely, **Solid Video Corporation**;

**WHEREAS**, on **25 January 2024 at 10:00 am**, the deadline of bid submission, the secretariat received one (1) bid from **Solid Video Corporation**, and **on the same day at 10:30 am**, the BAC conducted a preliminary examination of the submitted bids at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

**WHEREAS**, after the said examination, the bid of **Solid Video Corporation** was declared “passed” and rated for evaluation;

**WHEREAS**, after careful examination, the BAC Technical Working Group (TWG) verified the accuracy of **Solid Video Corporation’s** bid, as follows;
