



BAC RESOLUTION NO. 2024-11
RECOMMENDING THE AWARD OF CONTRACT OF
RFQ NO. 2024-002 TO DARA CONSUMER GOODS

WHEREAS, the Buildings and Grounds of Administrative Division requested for **Supply, Delivery, Installation, and Commissioning of the People's Television Network, Inc. Gate Arch Signage**, with an Approved Budget for Contract (ABC) of **One Hundred Thirty-Eight Thousand Pesos (Php138,000.00)**;

WHEREAS, such approved request was certified by the BAC Secretariat as included in APP 2024 as of date of request marked as **RFQ No. 2024-002** and posted at the PhilGEPS site on 23 February 2024;

WHEREAS, on 04 March 2024, five (5) prospective bidders submitted their bid offer or proposals, namely:

DIZON MEDIA ADVERTISING	-	Php 128,800.00
JOLAS CONSUMER ELECTRONICS TRADING	-	Php 130,000.00
DARA CONSUMER GOODS	-	Php 128,000.00
WARRENPRINT INC.	-	FAILED
ANGLOWEALTH ENTERPRISES	-	FAILED

WHEREAS, during the bid opening, **DIZON MEDIA ADVERTISING, JOLAS CONSUMER ELECTRONICS TRADING** and **DARA CONSUMER GOODS** submitted a complete required eligibility requirements and marked for further evaluation;

WHEREAS, WARRENPRINT INC., and **ANGLOWEALTH ENTERPRISES'** bid was declared failure due to the non-submission of detailed breakdown of costs, including materials, labor, transportation, and any additional charges;

WHEREAS, after careful validation, the Technical Working Group (TWG) finds that the eligibility requirements of Dizon Media Advertising, Jolas Consumer Electronics Trading, and Dara Consumer Goods were all complete and compliant with the technical specifications and their bid offer or proposals are all well within the PTNI's Approved Budget for the Contract of One hundred thirty-eight thousand pesos (Php 138,000.00);


WHEREAS, the TWG finds the bidder **DARA CONSUMER GOODS** with the Lowest Calculated and Responsive Quotation (LCRQ) and is capable to supply, deliver, and install the the aforementioned project;

- 1) Recommend the award of contract to **DARA CONSUMER GOODS** which submitted the Lowest Calculated and Responsive Quotation for the **Supply, Delivery, Installation, and Commissioning of the People's Television Network, Inc. Gate Arch Signage** in the amount of **One hundred twenty-eight thousand pesos (Php128,000.00)** inclusive of taxes, duties and other levies according to the delivery schedule proposed by the bidder and accepted by the end-user;
- 2) Direct the Secretariat to process all documents necessary for the finalization of the project.
