

BAC RESOLUTION NO. 2024-012 DECLARATION OF AGB NIELSEN MEDIA RESEARCH PHILIPPINES INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER (SCRB) AND RECOMMENDATION OF AWARD FOR ITB NO. 2024-0001

WHEREAS, Research Unit requested for the "Provision of Television Audience Measurement (TAM) AdHoc Reports" with an Approved Budget for the Contract of One Million One Hundred Thousand Pesos (PhP 1,100,000.00) which the Bids and Awards Committee review through pre-procurement conference to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid the said request through Competitive Bidding under ITB No. 2024-0001 by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 12 April 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

WHEREAS, in response to the said advertisement, only one (1) bidder bought the bidding documents namely, AGB Nielsen Media Research Philippines Inc.;

WHEREAS, on 25 April 2024 at 10:00 am, the deadline of bid submission, the secretariat received one (1) bid from AGB Nielsen Media Research Philippines Inc., and on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

WHEREAS, after the said examination, the bid of AGB Nielsen Media Research Philippines was declared "passed" and rated for evaluation;

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of AGB Nielsen Media Research Philippines Inc. bid, as follows, which the BAC adopted and declared as the Single Calculated Bid subject to post-qualification;
