## BAC RESOLUTION NO. 2024-009 RECOMMENDATION FOR THE CONTRACT EXTENSION BETWEEN THE PEOPLE'S TELEVISION NETWORK, INC. AND THE 168 SECURITY INC.

WHEREAS, the People's Television Network, Inc. (PTNI) through its Bids and Awards Committee (BAC) conducted procurement and awarded the contract of Security Services with Invitation to Bid No. 2021-0012R to 168 Security Inc. last 22 November 2021 in accordance with Republic Act (RA) No. 9184 and its 2016 revised Implementing Rules and Regulations (IRR);

WHEREAS, no procurement was made prior to the expiration of the said contract on 22 November 2022, due to the issuance of Memorandum Circular No. 3 by the Office of the President;

WHEREAS, the BAC issued Resolution No. 2022-047 recommending the extension of contract with 168 Security Inc. in accordance with the Government Procurement Policy Board (GPPB) Resolution no. 023-2007, entitled "Approving and Adopting the Revised Guidelines on the Extension of Contracts for the General Support Services" until the completion of new procurement activities to ensure the continuity of the security services;

WHEREAS, pursuant to the Government Policy Procurement Board (GPPB) Resolution No. 023-2007, entitled "Approving and Adopting the Revised Guidelines on the Extension of Contracts for the General Support Services", the PTNI-BAC recommended the extension of the contract until the completion of the procurement activities through the issuance of BAC Resolution No. 2022-047 to ensure the continuity of the security services;

WHEREAS, the GPPB issued Resolution No. 06-2022 dated 12 September 2022 titled "Approving the Guidelines on the Renewal of Regular and Recurring Services" and included as Appendix 37 of RA 9184 and its IRR which amended the conditions and procedures for the extension of contracts for Regular and Recurring Services which repealed relevant provisions of GPPB Resolution No. 023-2007:

WHEREAS, item no. 5.2 of the Appendix 37 of RA 9184 and its IRR, provides that "the duration for each contract extension shall not exceed three (3) months. However, the total combined period covering all contract extensions shall not exceed six (6) months";

WHEREAS, upon careful review and consideration of the guidelines on the renewal of regular and recurring services, the contract extension will reach its sixth month on 22 May 2023. Thus, the prohibition of another period of contract extension which the End-user representative requested for the renewal of the contract of security services between PTNI and 168 Security, Inc.;

**WHEREAS**, the BAC issued resolution no. 2023-006 recommending the renewal of contract between PTNI and 168 Security, Inc. pursuant to Appendix 37 of RA 9184 and its IRR from 23 May 2023 to 24 May 2024;

WHEREAS, on 12 April 2024, the End-user submitted a request for the procurement of security services;

- 1. Inclusion of the Contract Extension in the Annual Procurement Plan;
- 2. Extension of contract between PTNI and 168 Security, Inc. for one (1) month or until 25 June 2024 in accordance with Appendix 37 of RA 9184 and its IRR.
