- 6. Existing defective parts/accessories shall be turned over to (PTNI) as waste materials.
- 7. The supplier/system integrator shall provide a technical report on the status of the project/repair/parts/service, especially at the time of completion/operation.
- 8. The supplier/system integrator shall conduct actual testing, commissioning, and basic set-up for normal operation as a requirement for the issuance of certificate of final acceptance.
- 9. The supplier/system integrator shall provide technical support at any given time, especially in times of emergency situation whether out of warranty period.
