

6. The supplier/system integrator shall conduct actual testing, commissioning, and basic set-up for normal operation as a requirement for the issuance of certificate of final acceptance.
7. The supplier/system integrator shall provide technical support at any given time, especially in times of emergency situation whether out of warranty period.



8. The winning bidder shall submit an undertaking as a proof that the supplied spare parts are original.

**DELIVERY PERIOD:**

Within thirty (30) calendar days upon signing of Notice to Proceed.

**WARRANTY:**

The repaired equipment/unit/parts/accessories should have one (1) year warranty.
