This bulletin is being issued to revise/clarify certain portions of the bidding documents. This shall form an integral part of the bidding document for the above-stated project.

1	Will the Certificates of Performance Satisfaction come from the bidders, or from the bidders' clients?	This should come from the bidders' clients
2	Can the bidders provide Certificates of Performance Satisfaction from any of their completed projects within the last three (3) years?	Yes but it shall be a CCTV related installation project
3	Should the Certificates of Performance Satisfaction indicate that they are issued to the bidders for bidding purposes?	Yes, the Certificates of Performance Satisfaction shall indicate that it is being issued for bidding purposes only
4	Do the bidders need to submit a Philippine Contractors Accreditation Board (PCAB) license?	No.
5	Will the work related to the installation, testing, and commissioning of the project be conducted during or after office hours?	The bidder may conduct installation, testing, commissioning and other work related in the areas without ongoing programs. However, all works that require drilling shall be done after office hours.
6	At present, the delivery period of the project states Thirty (30) calendar days upon signing of Notice to Proceed. Can this be adjusted to Sixty (60) calendar days?	Yes, delivery period is hereby adjusted from within thirty (30) calendar days to sixty (60) calendar days upon signing of Notice to Proceed.

10	<p>Does PTV have an existing Cat-6 Cable mentioned under Item 16 of Section VII. Technical Specifications, or the bidder needs to supply and deliver a brand new cable?</p>	<p>PTV doesn't have Cat-6 Cable.</p> <p>All cables (including Cat-6 Cable) needed for the installation shall be provided by the winning bidder</p>
11	<p>Item 14 of Section VII. Technical Specifications states that "8 10/100/1000 Mbps Ethernet ports" are needed for the "Fiber Optical Switch 8 SFP 2RJ45 requirement", does the end-user mean 10/100/1000 Mbps Ethernet ports?</p>	<p>The requirements is being revised to:</p> <p>Fiber Optical Switch 8 SFP 2RJ45</p> <ul style="list-style-type: none"> • 8 10/100/1000 Mbps Ethernet ports • 2 1.25-Gbps fiber ports • 8 port SFP 2 RJ45 converter
12	<p>What is the required mounting type of "Server Cabinet 16U"?</p>	<p>It can be wall mounted or floor mounting</p>
13	<p>How many "4 PORTS POE SWITCH" are required to be delivered?</p>	<p>It is stated as one lot as the quantity will depend on the supplied CCTV</p>
14	<p>Please clarify what item 10 under Section VII. Technical Specifications means, specifically the requirement "Drive Bays supported up to 16" under 8TB Surveillance Hard Drive 24/7 Operation?</p>	<p>The supplied Hard Drive shall have this feature.</p>
15	<p>Do you need additional switches for the Bullet IPC Camera 5MP and Dome IPC Camera 5MP?</p>	<p>It will depend on the network setup and configuration supplied</p>
16	<p>The 8 pieces "8TB Surveillance Hard Drive" will not be enough for the storage of the 3-month video recordings coming from the 5MP cameras.</p>	<p>The required storage capacity is hereby adjusted from three (3) months to one (1) month</p>

	Will this be acceptable to the end-user?	
17	<p>The 8 pieces "8TB Surveillance Hard Drive" will not be enough for the storage of the 3-month video recordings coming from the 5MP cameras.</p> <p>Is the end-user amenable to changing this requirement to 4MP cameras instead?</p>	No, we will still require 5MP Cameras, however the required storage capacity is hereby adjusted from three (3) months to one (1) month
18	<p>Item 1 under Section VII. Technical Specifications requires the bidder to supply and deliver a 64CH Network Video Recorder.</p> <p>However, the surveillance monitor being required under item 15 is only 55".</p> <p>Can the end-user confirm that the other monitor will serve as an extender?</p>	Yes, the other monitor will serve as extender for monitoring purposes
19	<p>Item 15 of Section VII. Technical Specifications states that the monitor should support multiple signals such as HDMI, DP, VGA, and USB.</p> <p>However, new monitors no longer have a VGA port.</p> <p>Will monitors without VGA acceptable to the end-user?</p>	Yes, VGA input will not be required on the Surveillance Monitor
20	Will the Surveillance Monitor (55") run for 24/7?	Yes
21	Will the Network Video Recording (NVR) 64CH run 24/7 monitoring?	Yes
22	Will the end-user provide a floor plan and camera location to the bidders?	Please see Annex "A"

2	In Section V. Special Conditions of Contract, item 2.2 Payment shall only be made within thirty (30) calendar days after the appropriate documents and procedures or the like have been complied with as mandated by existing government rules and regulations
3	In Section I. Invitation to Bid, number 5 A complete set of Bidding Documents may be acquired by interested Bidders on 24 July 2024 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of one thousand pesos (PhP 1,000.00) . The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.

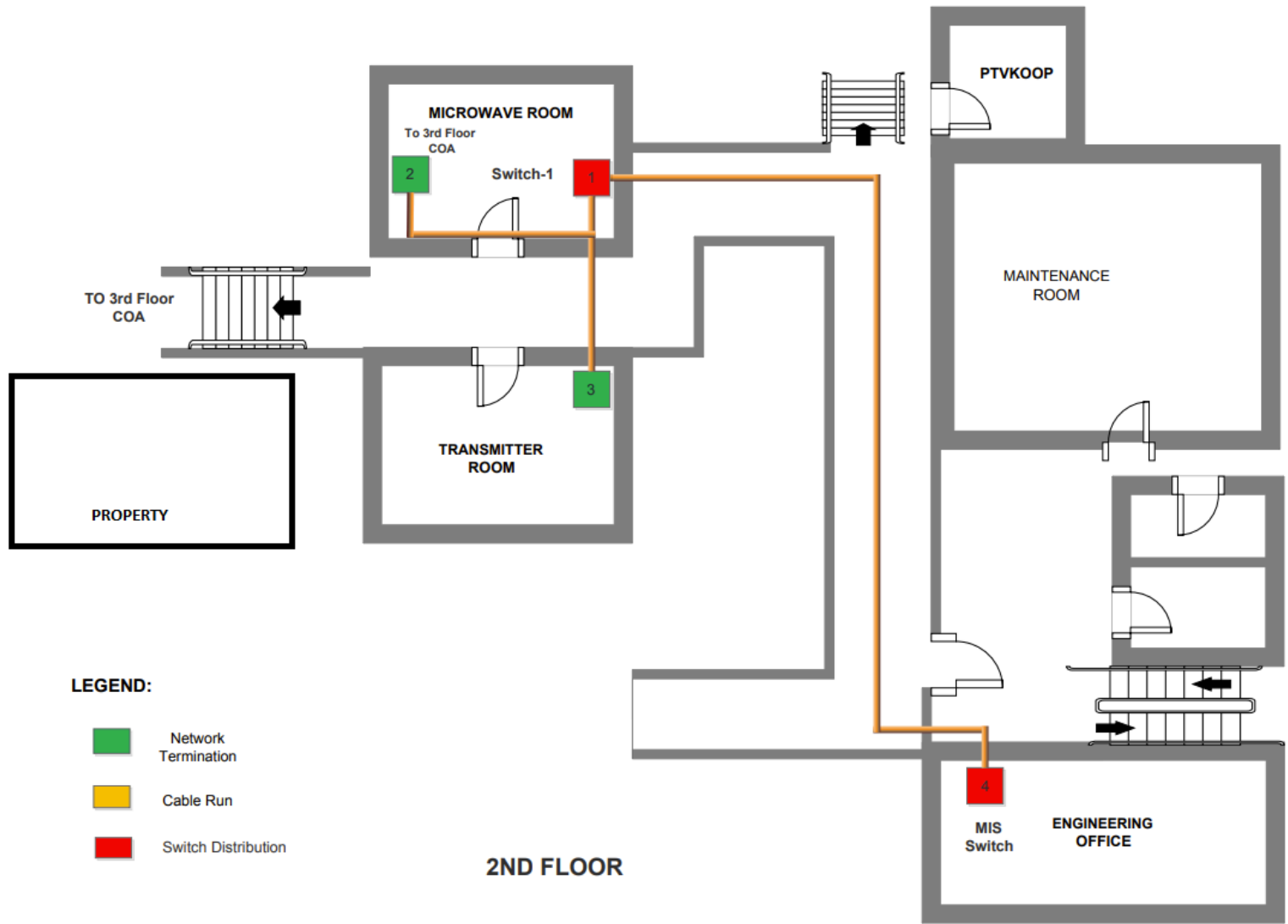

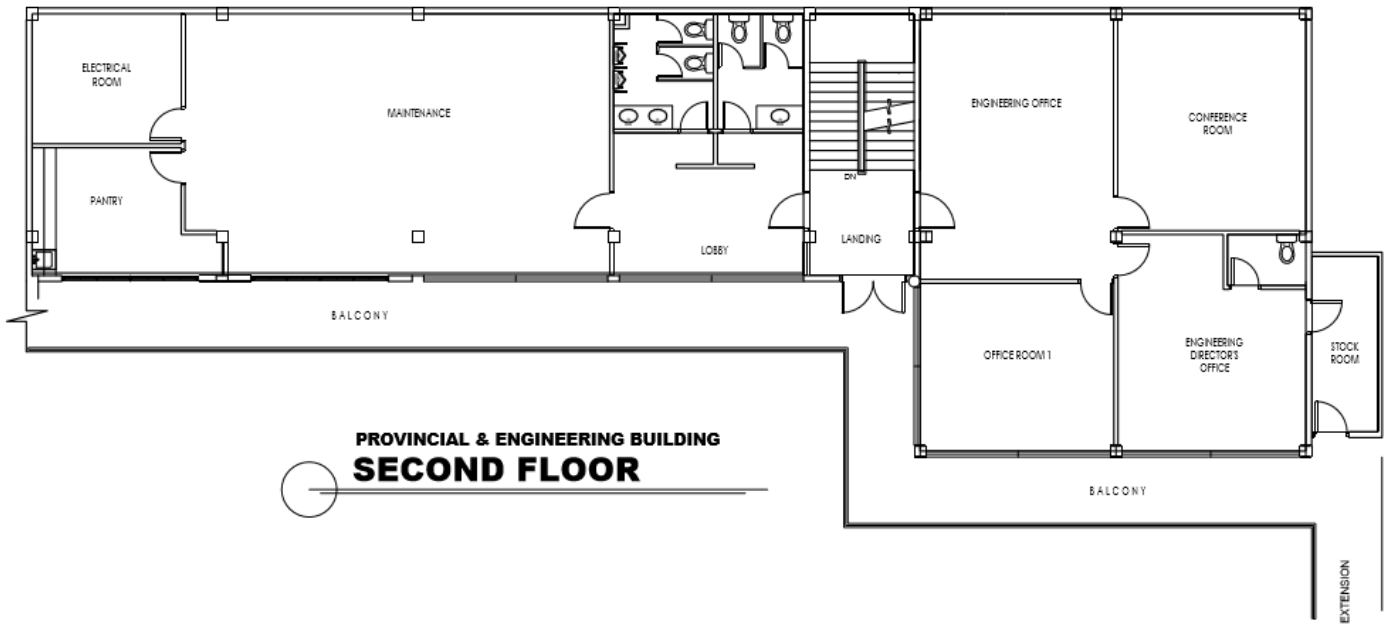

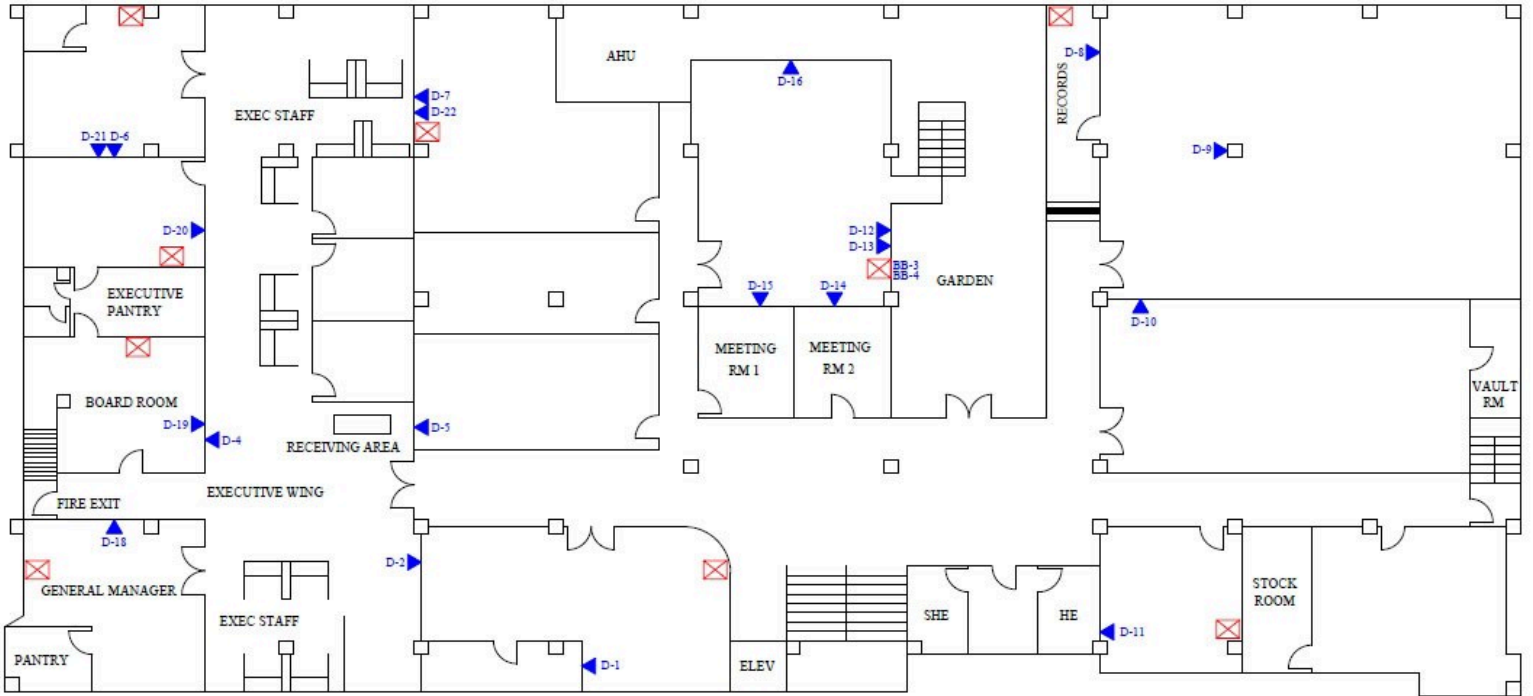






GROUND FLOOR PLAN

Section VIII. Checklist of Technical and Financial Documents

I. TECHNICAL COMPONENT ENVELOPE

Class "A" Documents

Legal Documents

- (a) Valid PhilGEPS Registration Certificate (Platinum Membership) (all pages) **in accordance with Section 8.5.2 of the IRR;**

Technical Documents

- (b) Statement of the prospective bidder of all its ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid; **and**
- (c) Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid, except under conditions provided for in Sections 23.4.1.3 and 23.4.2.4 of the 2016 revised IRR of RA No. 9184, within the relevant period as provided in the Bidding Documents; **and**
- (d) Original copy of Bid Security. If in the form of a Surety Bond, submit also a certification issued by the Insurance Commission **or** Original copy of Notarized Bid Securing Declaration; **and**
- (e) Conformity with the Technical Specifications, which may include production/delivery schedule, manpower requirements, and/or after-sales/parts, if applicable; **and**
- (f) Original duly signed Omnibus Sworn Statement (OSS) **and** if applicable, Original Notarized Secretary's Certificate in case of a corporation, partnership, or cooperative; or Original Special Power of Attorney of all members of the joint venture giving full power and authority to its officer to sign the OSS and do acts to represent the Bidder.

Additional Documents

- (g) The bidder shall submit system integration drawings with line diagrams.
- (h) The bidder shall submit three (3) Certificates of Performance Satisfaction, with at least Very Satisfactory Rating, from any client with whom the bidder has a completed project within the last three (3) years to ensure optimal customer satisfaction and to support that the bidder is in the industry for at least three (3) years.
- (i) **The bidder shall submit an undertaking through Notarized Certificate that it offers a CCTV Device Model in its latest model / Brand new and not in the end of life**
- (j) **Certificate of Site Inspection**



Financial Documents

- (k) The prospective bidder's computation of Net Financial Contracting Capacity (NFCC) or A committed Line of Credit from a Universal or Commercial Bank in lieu of its NFCC computation.

Class "B" Documents

- (l) If applicable, a duly signed joint venture agreement (JVA) in case the joint venture is already in existence or duly notarized statements from all the potential joint venture partners stating that they will enter into and abide by the provisions of the JVA in the instance that the bid is successful.

II. FINANCIAL COMPONENT ENVELOPE

- (m) Original of duly signed and accomplished Financial Bid Form; **and**
- (n) Original of duly signed and accomplished Price Schedule(s).

Other documentary requirements under RA No. 9184 (as applicable)

- (o) [For foreign bidders claiming by reason of their country's extension of reciprocal rights to Filipinos] Certification from the relevant government office of their country stating that Filipinos are allowed to participate in government procurement activities for the same item or product.
- (p) Certification from the DTI if the Bidder claims preference as a Domestic Bidder or Domestic Entity.
