

BAC RESOLUTION NO. 2024-025 DECLARATION OF PROGRESS HOME & OFFICE FURNISHINGS AS THE BIDDER WITH SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR ITB NO. 2024-0003

WHEREAS, Public Affairs, Purchasing Section, Research Unit, Corporate Planning Office, Project Management Office, Property Section, Finance Division, Gender and Development, PTNI-PCSO Unit, News Division, Broadcast Facility Monitoring Unit, Program Production Services Division, Bids and Awards Committee, Office of the General Manager, and Traffic Section submitted requests consolidated into one lot titled as "Supply and Delivery of Various Office Furniture" with an Approved Budget for the Contract of one million two hundred fifty thousand pesos (PhP 1,250,000.00) which the previous Bids and Awards Committee (BAC) chaired by Mr. Benjamin J. Asakil reviewed through the pre-procurement conference on 3 May 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its previous BAC, advertised the invitation to bid of the said consolidated request through **Competitive Bidding** under **ITB No. 2024-0003** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 3 June 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only Progress Home & Office Furnishings bought the bidding documents;

WHEREAS, on 18 June 2024 at 10:00 am, the deadline of bid submission, the secretariat received only one (1) bid from Progress Home & Office Furnishings and on the same day at 10:30 am the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet declared the the bid of Progress Home & Office Furnishings as passed and eligible for further evaluation;

WHEREAS, there was a delay in the process due to the appointment of a new general manager of the network on 18 June 2024 and reconstitution of BAC on 26 June 2024 through office order no. 2024-01;

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

- 1. The bidder used **Progress Home and Office Furnishings/ Verde** Linear Corporation as company name in the bid form which will be evaluated during post-qualification
- 2. Progress Home and Office Furnishings/ Verde Linear Corporation submitted a bid offer that is well within the Approved Budget for the Contract as follows:

FINAL BID ABSTRACT

3. Found **Progress Home and Office Furnishings/ Verde Linear Corporation** as the bidder with the Single Calculated Bid (SCB)

WHEREAS, upon the submission of the post-qualification requirements of **Progress Home and Office Furnishings/ Verde Linear Corporation** the TWG verified, validated, and ascertained the veracity, authenticity and validity of legal, technical and financial requirements of the SCB and found the following:

- 1. Confirmed the dimension of the 14-Seater Conference Table of W400cm x D120cm x H75cm should be L400cm x W120cm x H75cm
- 2. The required measurements of the Gondola Set are:
 - 5 Layer, Center Island Dimension: at least H175cm x L260cm x W75cm
 - 5 Layer, End Type Dimension: at least H175cm x L90cm x w 75cm, with side panel

The said bidder submitted a brochure indicating the measurements "5 Layer, Center Island Dimension: H195cm x L183cm x W93cm End Type Dimension: H195cm x L50cm x W93cm" which the end-user accepted.

WHEREAS, the BAC also verified the following after the presentation of post-qualification report:

1. The measurements of the Gondola Set indicated in the "Description" of Brochure of Items Offered are:

"5 Layer, Center Island Dimension: at least H175cm x L260cm x W75cm" 5 Layer, End Type Dimension: at least H175cm x L90cm x w 75cm, with side panel"

While the measurements under "Photos of items offered" are: "5 Layer, Center Island Dimension: H195cm x L183cm (90cm + 93cm) x W 93cm End Type Dimension: H195cm x L50cm x W93cm"

Progress Home and Office Furnishings/ Verde Linear Corporation clarified that what is shown in the brochure (Photos of items offered) is not their offer but a mere representation and cross-reference photo of the Gondola Set. The required dimension is customized and they do not have the actual size on hand. The offered Gondola Set shall be based on the Technical Specifications required in the bidding documents

2. The bidder used Progress Home and Office Furnishings/ Verde Linear Corporation as company name which was supported by a Securities and Exchange Commission (SEC) Certificate with Company Reg. No. CS093-000320 stating that Verde Linear Corporation is doing business under the trade name of Progress Home and Office Furnishings

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED** to:

- Declare Progress Home and Office Furnishings as the bidder with Single Calculated and Responsive Bid (SCRB) based on the thorough evaluation and findings of TWG and BAC in the amount of one million one hundred forty four thousand one hundred eighty pesos (PhP 1,144,180.00) inclusive of taxes, duties and other levies
- Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the SCRB for the contract of "Supply and Delivery of Various Office Furniture", ITB No. 2024-0003
- 3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution
