The winning bidder must set up the implementation of maintenance treatment program and monitoring services of the following:

- 1. Coordinate with the Building and Grounds Section.
- 2. Conduct inspection and evaluation of the whole system to determine the necessity of dosing.
- 3. Provide a data sheet for the weekly water treatment program.
- 4. Shall provide technical supervision during the first day of implementation of the treatment.
- 5. Shall conduct weekly chemical treatment dosing on-site.
- 6. Shall conduct once a month monitoring and water sampling analysis to monitor the efficacy of the treatment chemicals.
- Shall make the necessary recommendation and/or adjustment on the dosing including the operation parameters, shall be submitted to the Building and Grounds Section.
- 8. Shall perform once a year pressurized mechanical siphoning cleaning schedule of the three (3) units cooling tower







- 9. The winning bidder shall provide two (2) pieces of measuring cup for chemicals.
- 10. The winning bidder shall provide Material Safety Data Sheet (MSDS).
