CANCELLATION OF BIDDING OF DESIGN, SUPPLY, DELIVERY, INSTALLATION, INTEGRATION, TESTING, COMMISSIONING, AND TRAINING FOR ONE (1) SET DIGITAL TV TRANSMISSION EQUIPMENT WITH SATELLITE RECEIVER AND ANTENNA SYSTEMS FOR PTV LEGAZPI OF THE PEOPLE'S TELEVISION NETWORK, INC. (PTNI), ITB NO. 2024-0011

WHEREAS, Provincial Network Division requested for the procurement of "Design, Supply, Delivery, Installation, Integration, Testing, Commissioning, and Training for One (1) Set Digital TV Transmission Equipment with Satellite Receiver and Antenna Systems for PTV Legazpi of the People's Television Network, Inc. (PTNI)" with an Approved Budget for the Contract (ABC) of twenty million pesos (PhP 20,000,000.00) which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on 02 October 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid of the said request through Competitive Bidding under ITB No. 2024-0011 by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on 5 October 2024;

WHEREAS, on 16 October 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, the Committee received a number of inquiries and clarifications from prospective bidders on the project requirements and technical specifications;

WHEREAS, on 20 November 2024 the End-user Representative through a memorandum stating that in view of the number of inquiries from the prospective bidders for the procurement of Digital Transmitter for our station in PTV Legazpi, the Engineering Division and Provincial Network Division recommend the cancellation of the procurement process to check and revisit the Project Requirements of the said project;

WHEREAS, item 10 of Section I. Invitation to Bid of the Bidding Documents stated that the People's Television Network, Inc. (PTNI) reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RECOMMEND** to the Head of the Procuring Entity (HoPE), to:

- 1. Cancel the procurement of the project through a declaration of failure of bidding pursuant to Section 41 of RA 9184 and its revised IRR and based on the recommendation of the End-user representative
- 2. Instruct the End-user representative to revisit the project requirements and technical specifications as part of mandatory review
- 3. Instruct the Secretariat to return the documents and bid bulletins to the End-user representative for mandatory review
