





BAC RESOLUTION NO. 2024-036 DECLARATION OF POST-DISQUALIFICATION OF COM PARTS COMPUTER SALES' BID AND FAILURE OF BIDDING FOR ITB NO. 2024-0004

WHEREAS, the People's Television Network, Inc. (PTNI), through its Bids and Awards Committee (BAC), advertised the invitation to bid for the procurement of "Supply, Delivery, Installation, Testing, Training, and Commissioning of Closed-Circuit Television (CCTV) for the People's Television Network, Inc. (PTNI)" with an Approved Budget for the Contract of one million pesos (PhP 1,000,000.00) through Competitive Bidding under ITB No. 2024-0004;

WHEREAS, after the preliminary examination of submitted bid, the BAC declared the bids of (1) AVN Electronics Engineering Services Co., (2) Riley Corporation and (3) Com Parts Computer Sales as passed and eligible for further evaluation;

WHEREAS, the BAC declared the bid of AVN Electronics Engineering Services Co., as the bidder with the Lowest Calculated Bid (LCB) based on the observation and findings of the Technical Working Group (TWG) through BAC Resolution No. 2024-028;

WHEREAS, through BAC Resolution No. 2024-031, AVN Electronics Engineering Services Co., was disqualified due to its failure to comply with the required similar contract for its Single Largest Completed Contract (SLCC) which caused the BAC to instruct the TWG to proceed to the post-qualification of the bidder with the second Lowest Calculated Bid, Riley Corporation;

WHEREAS, through BAC Resolution No. 2024-034, Riley Corporation was disqualified due to failure to comply with the required transfer rate of 1000 Mbps (Gigabit Ethernet) of its offered Fiber Optic Media Converter which supports only 10x100 which caused the BAC to instruct the TWG to proceed to the post-qualification of the bidder with the third Lowest Calculated Bid, Com Parts Computer Sales;

WHEREAS, upon the submission of the post-qualification requirements of Com Parts Computer Sales, the TWG verified, validated, and ascertained the veracity, authenticity and validity of the bidder's legal requirements, technical requirements and financial requirements and observed the following:

- The issuance date of Business Permit in the Annex A of the PhilGEPS registration is 22 January 2024 while issuance date in the submitted Business Permit is 25 January 2024
- The specifications stated in the submitted brochure of some offered items were copied from the requirements of the end-user representative.

- The offer of Network Video Recorder (NVR) 64CH cannot be verified in the submitted brochure. However, upon verification in the "Dahua Technology" website, the required supported network protocol such as IPv6, SNMP, IP Filter, PPPoE, & FTP has been verified and was deemed complied with the requirements:
- The offered 4 Ports POE Switch were found not compliant with the required specification of which it shall (1) support IEEE802.3, IEEE802.3u, IEEE802.3ab and IEEE802.3x standards, (2) MDI/MDIX self-adaptation, (3) RJ-45 port supports 10/100 Mbps self-adaptation, and conforms to 802.3at, and 802.3af power supply standards, (4) Port 1 supports Hi-PoE 60W power supply, (5) 250m PoE power supply, (6) wall mounting and mechanical anti-theft, (7) 53V DC power supply, and (8) supports PoE watchdog
- The offered Surveillance Monitor 55" were found not compliant with the following required specification (1) Built-in 3D Comb Filter And 3D Noise Reduction, (2) 6 ms Response Time for No Motion Blur, Judder, or Ghosting, (3) Compatible with VESA Mounting Pattern 400 mm X 400 mm, (4) 1.07b Colors for a Realistic and Immersive Visual Experience, (5) 178°/178° Wide Uninterrupted Viewing Angle and (6) Support Multiple Signals such as HDMI, DP, VGA, USB

WHEREAS, Section 34.1 of RA 9184 and its revised IRR, provides that post-qualification is conducted in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents;

WHEREAS, Section 34.7 of RA 9184 and its revised IRR, provides that if the BAC determines that the bidder fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it:

WHEREAS, Section 35.1 (c) of RA 9184 and its revised IRR, states that the BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements or failed post-qualification;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it hereby **RESOLVED** to:

1. Declare the post-disqualification of Com Parts Computer Sales, pursuant to Section 34 of RA 9184 and its revised IRR, due to its failure to comply to the required specifications of 4 Ports POE Switch and Surveillance Monitor 55";

- 2. Declare the failure of bidding pursuant to Section 35.1 (c) of RA 9184 and its revised IRR;
- 3. Notify the bidders and all other parties involved in the procurement process, on the result of the evaluation;
- Instruct the Secretariat to return the documents to the end-user for mandatory review of the project requirements, approved budget for the contract, and other necessary documents in accordance with RA 9184 and its IRR
- Direct the Secretariat to cause republication of the project after the period of mandatory review
