



**BAC RESOLUTION NO. 2024-032
RECOMMENDING THE AWARD OF CONTRACT TO
AGENCE FRANCE-PRESSE FOR ITB NO. 2024-0005**

WHEREAS, the News Division requested for the “**Provision of Foreign Newswire for People’s Television Network, Inc.**” with an Approved Budget for the Contract of **one million five hundred thousand pesos (PhP 1,500,000.00)** which the Bids and Awards Committee reviewed and finalized through pre-procurement conference to confirm its readiness for the procurement;

WHEREAS, the People’s Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid for the said request through **Competitive Bidding** under **ITB No. 2024-0005** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR);

WHEREAS, on **8 August 2024**, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

WHEREAS, only (1) bidder, **Agence France-Presse**, bought the bidding documents;

WHEREAS, on **22 August 2024 at 10:00 am**, the deadline of bid submission, the BAC Secretariat received one (1) bid from **Agence France-Presse**, and **on the same day at 10:30 am**, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and via video conferencing using Google Meet;

WHEREAS, after the said examination, the bid of **Agence France-Presse** was declared “passed” and rated for evaluation;

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of **Agence France-Presse’s** bid, as follows, which the BAC adopted and declared as the bidder with the **Single Calculated Bid** subject to post-qualification;

1. Declare **Agence France-Press** as the bidder with **Single Calculated and Responsive Bid (SCRB)** based on the thorough evaluation and findings of TWG and BAC in the amount of **one million five hundred thousand pesos (PhP 1,500,000.00)** inclusive of taxes, duties and other levies
2. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the SCR B for the contract of **“Provision of Foreign Newswire for People’s Television Network, Inc.”, ITB No. 2024-0005**
3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution
