

BAC RESOLUTION NO. 2024-046
DECLARATION OF BMH SYSTEMS SOLUTIONS INC. AS THE BIDDER WITH
LOWEST CALCULATED AND RESPONSIVE BID (LCRB) FOR ITB NO. 2024-0007

WHEREAS, Engineering Division requested for the procurement of “Supply, Delivery, Installation, Integration, Testing, Training, and Commissioning of 1-Set Digital Transmitter 4-Channels (1-Full High Definition (FHD) and 3-Standard Definition (SD) Programs) Head-end System with complete standard accessories for the People’s Television Network, Inc.” with an Approved Budget for the Contract of seven million seventy-three thousand one hundred seventy-seven pesos (PhP 7,073,177.00) which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on **21 August 2024** to confirm its readiness for the procurement;

WHEREAS, the People’s Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid of the said request through **Competitive Bidding** under **ITB No. 2024-0007** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on **30 August 2024**;

WHEREAS, on **10 September 2024**, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, three (3) prospective bidders, namely, (1) **8BTSI Corp.**, (2) **Media Convergence Inc.**, and (3) **BMH Systems Solutions Inc.** bought the bidding documents;

WHEREAS, on **24 September 2024** at **10:00 am**, the deadline of bid submission, the secretariat received three (3) bids from (1) **BMH Systems Solutions Inc.** (2) **8BTSI Corp.**, and (3) **Media Convergence Inc.**, and on the same day at **10:30 am**, the BAC conducted a preliminary examination of the submitted bids at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the BAC declared the bids of (1) **BMH Systems Solutions Inc.** (2) **8BTSI Corp.**, and (3) **Media Convergence Inc.**, as passed and eligible for further evaluation;



WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

1. 8BTSI Corp.
 - a. It properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component
2. Media Convergence Inc.
 - a. It properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.
3. BMH Systems Solutions Inc.
 - a. It properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.

WHEREAS, the bidders were ranked as follows based on the calculated amount:

WHEREAS, through BAC Resolution No. 2024-033, the BAC declared **8BTSI CORP.** as the bidder with Lowest Calculated Bid (LCB) and directed the TWG to conduct post-qualification of the said bid after the submission of the required documentation;



WHEREAS, upon the submission of the post-qualification requirements of **8BTSI CORP.**, the TWG verified, validated, and ascertained the veracity, authenticity and validity of its legal, technical and financial requirements and found the following which caused the BAC to declare its disqualification and instruct the TWG to proceed to the post-qualification of the bidder with the second Lowest Calculated Bid, **Media Convergence Inc.**; through BAC Resolution No. 2024-035:

1. Discrepancy in the total value of outstanding contracts stated in the Statement of the prospective bidder of all its ongoing government and private contracts
2. The Head-end System is a component of the supplied equipment stated in the submitted Statement of the bidder's Single Largest Completed Contract (SLCC) that is compliant to the required similar contract.
3. **Non-submission of any product brochure/catalog/ brand needed in validation 3. Multiplexer Control Terminal**
4. **Non-compliance with the specification of the offered "Encoder" where it does not have dual power supply**
5. **Non-compliance in the specification of the offered "Multiplexer" where it has no bit rate limiter**
6. Discrepancy in the submitted computation of Net Financial Contracting Capacity (NFCC)

WHEREAS, upon the submission of the post-qualification requirements of **Media Convergence Inc.**, the TWG verified, validated, and ascertained the veracity, authenticity and validity of its legal, technical and financial requirements and found the following which caused the BAC to declare its disqualification and instruct the TWG to proceed to the post-qualification of the bidder with the third Lowest Calculated Bid, **BMH Systems Solutions Inc.**; through BAC Resolution No. 2024-037:

1. **Non-compliance with the specification of the offered "Encoder" where it does not have dual power supply and One-Seg capabilities**
2. **Non-compliance with the specification of the offered "Multiplexer Tecsys TS9600 RMX IP" where it has no bit rate limiter**
3. **The desktop computer for the "Multiplexer Control Terminal (MCT)" has Windows Home as the operating system, which does not meet the technical specification requiring a server OS.**
4. The similar contract "Supply, Delivery, and Installation of Multiplexers for Digital TV Headend" submitted for the Statement of the bidder's Single Largest Completed Contract (SLCC) is only a part of the whole Headend System.
5. The letterhead used in the Satisfactory Performance Certificate was from the bidder and not from the client.



WHEREAS, upon the submission of the post-qualification requirements of **BMH Systems Solutions Inc.**, the TWG conducted site inspection, verified, validated, and ascertained the veracity, authenticity and validity of legal, technical and financial requirements of the LCB and found that the said bidder is responsive to all requirements;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. Declare **BMH Systems Solutions Inc.**, as the bidder with **Lowest Calculated and Responsive Bid (LCRB)** based on the thorough evaluation and findings of TWG in the amount of ~~six~~ ⁸ **million nine hundred eighty thousand pesos (PhP 6,980,000.00)** inclusive of taxes, duties and other levies.
2. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the LCRB for the contract of **"Supply, Delivery, Installation, Integration, Testing, Training, and Commissioning of 1-Set Digital Transmitter 4-Channels (1-Full High Definition (FHD) and 3-Standard Definition (SD) Programs) Head-end System with complete standard accessories for the People's Television Network, Inc."**, ITB No. 2024-0007
3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
