

BAC RESOLUTION NO. 2024-047
DECLARATION OF BMH SYSTEMS SOLUTIONS INC. AS THE BIDDER WITH
SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR ITB NO. 2024-0009

WHEREAS, Provincial Network Division requested for the procurement of **"Supply and Delivery of Analog Transmitter Parts for Provincial Stations"** with an Approved Budget for the Contract (ABC) of **ten million five hundred seventy-four thousand pesos (PhP 10,574,000.00)** which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on **24 September 2024** to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid of the said request through **Competitive Bidding** under **ITB No. 2024-0009** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on **28 September 2024;**

WHEREAS, on 8 October 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, two (2) prospective bidders bought the bidding documents, namely, (1) **8BTSI Corp.** and (2) **BMH Systems Solution Inc.;**

WHEREAS, on 22 October 2024 at 2:00 pm, the deadline of bid submission, the secretariat received bids from (1) **8BTSI Corp.** and (2) **BMH Systems Solution Inc.** and **on the same day at 2:30 pm,** the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, pursuant to Section 31 of RA No. 9184 and its revised IRR, the bid of **8BTSI Corp.,** was disqualified as the amount of bid offer indicated in their bid form was higher than the ABC;

WHEREAS, after the said examination, the BAC declared the bid of BMH Systems Solution Inc. as passed and eligible for further evaluation;



WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

1. **BMH Systems Solution Inc.**
 - a. Submitted a properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.
 - b. The bid is within the approved budget and accurately calculated as indicated in the bid abstract.



Declare **BMH Systems Solutions Inc.**, as the bidder with **Single Calculated and Responsive Bid (SCRB)** based on the thorough evaluation and findings of TWG in the amount of **nine million seven hundred ninety three thousand six hundred thirty eight pesos and 40/100 pesos (PhP 9,793,638.40)** inclusive of taxes, duties and other levies.
2. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the **SCRB** for the contract of **"Supply and Delivery of Analog Transmitter Parts for Provincial Stations"**, ITB No. 2024-0009
3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
