



BAC RESOLUTION NO. 2024-048
DECLARATION OF POWER ACCESS ELECTRICAL SERVICES AS THE BIDDER WITH
SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR ITB NO. 2024-0008

WHEREAS, Provincial Network Division requested for the procurement of “Supply, Delivery, Installation, Testing, and Commissioning of one (1) unit of 75 KVA Prime Power Silent Type Generator Set Including Training of Personnel for PTV Cordillera Station” with an Approved Budget for the Contract (ABC) of one million seventy-six thousand six hundred forty pesos (PhP 1,076,640.00) which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on 5 September 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid on the said request through **Competitive Bidding** under **ITB No. 2024-0008** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on **28 September 2024**;

WHEREAS, on **8 October 2024**, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only **Power Access Electrical Services** bought the bidding documents;

WHEREAS, on **5 November 2024 at 10:00 am**, the deadline of bid submission, the secretariat received bid from **Power Access Electrical Services** and on the same day at **10:30 am**, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the BAC declared the bid of **Power Access Electrical Services** as passed and eligible for further evaluation;

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

1. Power Access Electrical Services

- a. Submitted a properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.
- b. The items indicated under Sec. 6 of the Schedule of Requirements in the bidding documents were stated as one (1) lot in the Price Schedule
- c. The bid is within the approved budget and accurately calculated as indicated in the bid abstract

WHEREAS, upon the submission of the post-qualification requirements of **Power Access Electrical Services**, the TWG verified, validated, and ascertained the veracity, authenticity and validity of legal, technical and financial requirements of the SCB and found the following:

1. Complied with item 1 75 kVA Prime Power Silent-Type Inverter Generator Set of section 7 under the detailed technical specification of the generator set.
2. Stated compliance with the following which will be verified during the implementation of the project
 - a. **Deconstruction of a section of the wall of the Generator Set room**
 - b. **Wiring and Installation**
 - c. **Dismantling and Hauling of existing single-phase generator set**
 - d. **Reconstruction of the previously deconstruction section of the wall of the Generator Set room**
 - e. **Test Equipment and Tools**
3. Conforms to the financial, legal, and technical requirements.

NOW, THEREFORE, for and in consideration of the foregoing, **WE,** the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. Declare **Power Access Electrical Services**, as the bidder with **Single Calculated and Responsive Bid (SCRB)** based on the thorough evaluation and findings of TWG in the amount of **nine hundred ninety seven thousand pesos (PhP 997,000.00)** inclusive of taxes, duties and other levies.
2. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the SCRB for the contract of **"Supply, Delivery, Installation, Testing, and Commissioning of one (1) unit of 75 KVA Prime Power Silent Type Generator Set Including Training of Personnel for PTV Cordillera Station", ITB No. 2024-0008**
3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
