





BAC RESOLUTION NO. 2024-049 DECLARATION OF POST-DISQUALIFICATION OF NEWTRENDS INTERNATIONAL CORPORATION'S BID AND FAILURE OF BIDDING FOR ITB NO. 2024-0014

WHEREAS, Administrative Division requested for the procurement of "Supply and Delivery of Loyalty Award Tokens for PTV@50 Anniversary" with an Approved Budget for the Contract (ABC) of one million six hundred sixty thousand pesos (Php 1,660,000.00) which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on 25 October 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid on the said request through Competitive Bidding under ITB No. 2024-0014 by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on 31 October 2024;

WHEREAS, on 8 November 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only Newtrends International Corporation bought the bidding documents:

WHEREAS, on 5 November 2024 at 10:00 am, the deadline of bid submission, the secretariat received bid from Newtrends International Corporation and on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Of fice, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the BAC declared the bid of Newtrends International Corporation as passed and eligible for further evaluation;

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

- 1. Newtrends International Corporation
 - a. Offered goods are from China but used "Bid Form for Goods Offered from within the Philippines". Accordingly, for bidder offering imported products, the form to be used by the bidder shall

- be the Price Schedule for Goods Offered from Abroad, even if the goods are yet to be delivered from abroad.
- b. Calculated bid offer of PHP 1,660,147.00 is higher and exceeds the ABC of PHP 1,660,000.00

WHEREAS, Section 31.1 of RA 9184 and its IRR provides that the ABC shall be the upper limit or ceiling for acceptable bid prices. If a bid price, as evaluated and calculated in accordance with this IRR, is higher than the ABC, the bidder submitting the same shall be automatically disqualified. There shall be no lower limit or floor on the amount of the award:

WHEREAS, Section 35.1 (c) of RA 9184 and its revised IRR, states that the BAC shall declare the bidding a failure when all bids fail to comply with all the bid requirements or failed post-qualification;

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- Declare and recommend to the Head of Procuring Entity (HoPE) the disqualification of Newtrends International Corporation due to the submission of calculated bid price that is higher than the ABC pursuant to Section 31.1 of RA 9184 and its IRR
- 2. Declare the failure of bidding pursuant to Section 35.1 (c) of RA 9184 and its revised IRR
- 3. Direct the Secretariat to cause republication of the project after the period of mandatory review
- 4. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
