



**BAC RESOLUTION NO. 2024-052**  
**DECLARATION OF POST-DISQUALIFICATION OF MEDIA CONVERGENCE INC.'S BID**  
**AND FAILURE OF BIDDING FOR ITB NO. 2024-0010R**

**WHEREAS**, the Engineering Division requested for the procurement of **"Supply, Delivery, Testing, Commissioning, and Training of One (1) Unit Satellite Encoder with integrated Modulator of the Fly Away System"** with an Approved Budget for the Contract (ABC) of **two million seven hundred thousand pesos (PhP 2,700,000.00)** which the Bids and Awards Committee (BAC) conducted mandatory review for the rebidding of the said request on **26 September 2024** to confirm its readiness for the procurement;

**WHEREAS**, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid for the said request through **Competitive Bidding** under **ITB No. 2024-0010R** by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on **5 October 2024**;

**WHEREAS**, on **15 October 2024, 10:00 am** the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

**WHEREAS**, in response to the said advertisement, only **Media Convergence Inc.** bought the bidding documents

**WHEREAS**, on **29 October 2024 at 10:00 am**, the deadline of bid submission, the secretariat received a bid from **Media Convergence Inc.** and on the same day at **10:30 am**, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

**WHEREAS**, after the said examination, the BAC declared the bid of **Media Convergence Inc.** as passed and eligible for further evaluation;

**WHEREAS**, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

**1. Media Convergence Inc.**

- a. Submitted a properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and**

"Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.

- b. The cost of "PhP 0.00" offered by the bidder under columns 5, 6, and 7 in their "Goods offered from abroad form" was clarified where the bidder replied that "the shipment from their principal's factory is being handled by a partner forwarder delivered to office."
- c. The bid is within the approved budget and accurately calculated as indicated in the bid abstract

**WHEREAS**, through BAC Resolution No. 2024-040, the BAC declared **Media Convergence Inc.** as the bidder with Single Calculated Bid (SCB) based on the observation and findings of the TWG and will proceed to the post-qualification;

**WHEREAS**, upon the submission of the post-qualification requirements of **Media Convergence Inc.**, the TWG verified, validated, and ascertained the veracity, authenticity and validity of legal requirements, technical requirements and financial requirements of the SCB and found the following:

1. The submitted similar contract in the statement of Single Largest Completed Contracts (SLCC) was only an Encoder while the requirement is a **Satellite Encoder (and Satellite) Modulator**
2. The offered equipment has only one Input BNC connector while the requirement is at least four (4) BNC connectors
3. The video and audio encoding profiles of the offered equipment cannot be verified on the submitted brochure
4. Cannot properly identify the end user's technical specification requirement from the bidder's offered equipment since the end-user requires a satellite encoder with integrated modulator as indicated in the Bidding Documents while the bidder offers a two (2) or separate equipment to conform to the end user's requirements



**WHEREAS**, Section 34.1 of RA 9184 and its revised IRR, provides that post-qualification is conducted in order to determine whether the bidder concerned complies with and is responsive to **all the requirements and conditions as specified in the Bidding Documents**;

**WHEREAS**, Section 34.5 of RA 9184 and its revised IRR, provides that if the BAC determines that the bidder fails the criteria for post-qualification, it shall immediately notify the said bidder in writing of its post-disqualification and the grounds for it;

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. Declare and recommend to the Head of Procuring Entity (HoPE) the disqualification of **Media Convergence Inc.**, due to the non-compliance of the required similar contract in the statement of SLCC, required specification of Input BNC connector and absence of required video and audio encoding profiles specification in the brochure pursuant to Section 34.5 of RA 9184 and its IRR
2. Declare the failure of bidding pursuant to Section 35.1 (c) of RA 9184 and its revised IRR
3. Direct the Secretariat to cause republication of the project after the period of mandatory review
4. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
