





## BAC RESOLUTION NO. 2025-002 DECLARATION OF CMPT MANPOWER SERVICES AS THE BIDDER WITH SINGLE CALCULATED AND RESPONSIVE BID (SCRB) FOR ITB NO. 2024-0013

WHEREAS, Administrative Division - General Services requested for the procurement of "Provision of Janitorial Services" with an Approved Budget for the Contract (ABC) of five million two hundred ninety thousand two hundred three pesos and 8/100 (Php 5,290,203.08) which the Bids and Awards Committee (BAC) reviewed through pre-procurement conference on 28 October 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, published the invitation to bid on the said request through Competitive Bidding under ITB No. 2024-0013 by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) on 9 November 2024;

WHEREAS, on 19 November 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, two (2) bidders, namely, (1) Anchor Human Resources Development Corp. and (2) CMPT Manpower Services bought the bidding documents;

WHEREAS, on 3 December 2024 at 10:00 am, the deadline of bid submission, the secretariat received bids from (1) Anchor Human Resources Development Corp. and (2) CMPT Manpower Services and on the same day at 10:30 am, the BAC conducted a preliminary examination of the submitted bid at the BAC Secretariat Of fice, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, after the said examination, the BAC disqualified the bid of Anchor Human Resources Development Corp. and marked as failed bid due to the absence of National Labor Relations Commission (NLRC) certificates for Tagum City and Davao where it has ongoing contract/s;

WHEREAS, the bid of CMPT Manpower Services was declared passed and eligible for further evaluation:

WHEREAS, after careful examination, the Technical Working Group (TWG) verified the correctness of the eligible bidder's financial component and found the following:

- 1. CMPT Manpower Services
  - a. Submitted a properly accomplished and submitted a correct "Original of duly signed and accomplished Financial Bid Form" and "Original of duly signed and accomplished Price Schedule(s)" in its Financial Component.
  - b. The computations in the submitted cost breakdown of supplies for the "cost per janitor per year" (Table B+C divided by 15 janitors) indicates the figure amounting to Php 49,704.17 while the computation of TWG is Php 39,763.33. However, upon TWG recalculation of the figures reflected in the Bid Offer, the difference between bidders and TWG's calculation lies in the divisor used. Nevertheless, the final number indicated in their bid offer is the same with TWG's computation.
  - c. The bid is within the approved budget and accurately calculated as indicated in the bid abstract

WHEREAS, upon the submission of the post-qualification requirements of CMPT Manpower Services, the TWG verified, validated, and ascertained the veracity, authenticity and validity of legal, technical and financial requirements of the SCB and found the following:

- The similar contract submitted for the Statement of Single Largest Completed Contract (SLCC) is "Provision of Manpower Service Provider" which includes Janitorial Services
- 2. There is a typographical error in one of the requirements "complies with the Labor Laws and Other Social Legislation as mandated by Section 25.2 Implementing Rules and Regulations of R.A. No. 9148" which was confirmed to be R.A. No. 9184

WHEREAS, the BAC recalculated the bid offer and identified computational errors in the amount submitted by CMPT Manpower Services of which the figures indicated in "Column 9" (Php 351,451.85) multiplied by "Column 4" (15) should amount to Php 5,271,777.75;

WHEREAS, Section 12.3 (c) of RA No. 9184 and its IRR states that in case of discrepancies between the stated total price and the actual sum of prices of component items, the latter shall prevail;

NOW. THEREFORE, for and in consideration of the foregoing. WE, the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- 1. Declare CMPT Manpower Services, as the bidder with Single Calculated and Responsive Bid (SCRB) based on the thorough evaluation and findings of TWG in the amount of five million two hundred seventy one thousand seven hundred seventy-seven pesos and 75/100 (PhP 5,271,777.75) inclusive of taxes, duties and other levies.
- 2. Recommend to the Head of Procuring Entity (HoPE) the approval of the foregoing findings and issuance of Notice of Award in favor of the SCRB for the contract of "Provision of Janitorial Services". ITB No. 2024-0013
- 3. Immediately notify all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.
