





## BAC RESOLUTION NO. 2025-001 DECLARATION OF FAILURE OF BIDDING FOR THE CONSTRUCTION OF PERIMETER FENCE IN PTNI NAGA, ITB NO. 2024-0016

WHEREAS, Provincial Network Division requested for the procurement of "Construction of Perimeter Fence in PTNI Naga" with an Approved Budget for the Contract of one million one hundred forty seven thousand seven hundred seventy pesos and 93/100 (PhP 1,147,770.93) which the Bids and Awards Committee (BAC) reviewed and finalized through pre-procurement conference on 12 November 2024 to confirm its readiness for the procurement;

WHEREAS, the People's Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid of the said request through Competitive Bidding under ITB No. 2024-0016 by posting in the Philippine Government Electronic Procurement Service (PhilGEPS), the Network's website and in conspicuous places within the network's premises in accordance with the rules provided under Republic Act (R.A.) 9184 and its Implementing Rules and Regulations (IRR) 30 November 2024;

WHEREAS, on 06 December 2024, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, on 07 January 2025 at 10:00 AM, the deadline of bid submission, the secretariat did not receive any bids and on the same day at 10:30 am, the BAC convened at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, Section 35 (a) of RA No. 9184 and its revised IRR states that the BAC shall declare the bidding a failure when no bids were received;

**NOW, THEREFORE**, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it hereby **RESOLVED** to:

- 1. Declare the failure of bidding pursuant to Section 35 (a) of RA No. 9184 and its revised IRR
- Conduct mandatory review of the project requirements, approved budget for the contract, and other necessary documents in accordance with RA 9184 and its IRR
- 3. Direct the Secretariat to cause republication of the project after the mandatory review and its inclusion to the FY 2025 APP
