

- All replacement parts must be brand new and either original equipment manufacturer (OEM) or equivalent, and compatible with the existing gensets.
- The winning bidder must ensure the unit is fully operational following any service or repair and before departing the premises.
- In the event that replaced parts are found defective during testing, the winning bidder shall provide replacements without delay, at no additional cost to PTNI.
- If parts requiring replacement are identified that are outside the scope of the specifications, the winning bidder must immediately notify the end-user and obtain approval before replacing the parts. A separate quotation for the additional work must then be provided.
- The winning bidder shall transfer all removed parts to the PTNI end-user for proper disposal.
- Testing and commissioning.
- The prospective bidder should conduct an ocular inspection and obtain an inspection certificate from the end-user.

Warranty Period

- Three (3) months warranty on parts and workmanship.

Delivery Period

- Ten (10) working days upon signing of the Notice To Proceed (NTP).
