- 4) If parts requiring replacement are identified that are outside the scope of the specifications, the winning bidder must immediately notify the end-user and obtain approval before replacing the parts. A separate quotation for the additional work must then be provided.
- 5) The winning bidder shall transfer all removed parts to the PTNI end-user for proper disposal.
- 6) Testing and commissioning.
- 7) The prospective bidder should conduct an ocular inspection and obtain an inspection certificate from the end-user.
