BOARD RESOLUTION NO. 2020--013

WHEREAS, pursuant to Section 34 of Governance Commission for Government Owned and Controlled Corporations (GCG) Memorandum Circular No. 2012-07, otherwise known as the "Code of Corporate Governance for GOCCs, reminds that GOCCs are inherently mandated to be socially responsible to act and operate as good corporate citizens;

WHEREAS, pursuant to Section 33 of Governance Commission for Government Owned and Controlled Corporations (GCG) Memorandum Circular No. 2012-07, otherwise known as the "Code of Corporate Governance for GOCCs, reminding the duty of every GOCCs to be responsive to its Stakeholders such as its employees, communities, costumers, and other Stakeholders "who have the right to expect that the GOCC is being run in a prudent manner and with due regard to the interests of all Stakeholders";

Upon motion duly made and seconded, the Board of Directors of PTNI resolve as follows:

"RESOLVED, AS IT IS HEREBY RESOLVED, in fulfillment of the Network's Corporate Social Responsibility under GCG Memorandum Circular No. 2012-07, the Board hereby agrees to implement a Zumba program for physical enhancement of the Network employees to be held weekly and shall be executory upon communication to respective or concerned offices;

RESOLVED FURTHER, that the Board authorizes the Network General Manager to implement and provide the proper guidelines in adopting the Corporate Social Responsibility project;

RESOLVED FINALLY, that copies of this Board Resolution be furnished the various units and divisions in the Network and other concerned agencies, in order that they will be guided on the approval and authority herein extended.
