



**BAC RESOLUTION NO. 2025-09 RECOMMENDING THE AWARD OF CONTRACT FOR RFQ NO. 2024-064 TO PJ PEST CONTROL SERVICES**

**WHEREAS**, the Provincial Network Division requested for the Provision of **Pest Control Services for PTV Cordillera Station** with an Approved Budget for Contract (ABC) of **thirty-eight thousand one hundred sixty-six pesos and 67/100 (PhP 38,166.67)**, as certified by the BAC Secretariat as included in **APP 2024 - G-121** as of date of request;

**WHEREAS**, the People's Television Network, Inc. through its Bids and Awards Committee (BAC), sent the Request for Quotation (RFQ) for the said request through Negotiated Procurement under Small Value Procurement, and the approved request was marked as **RFQ No. 2024-064**;

**WHEREAS**, on **30 December 2024**, the BAC Secretariat sent the Request for Quotation (RFQ) to all known prospective bidders;

**WHEREAS**, in response to the sent RFQ, two (2) interested bidders submitted their quotations or proposals, namely **JTO Pest Control Services** and **PJ Pest Control Services**;

**WHEREAS**, on **13 January 2025**, during the opening of quotations/proposals, the BAC conducted a preliminary examination of the submitted bids and declared the following:

1. **JTO Pest Control Services** was **declared failed** due to non-submission of the Mayor's Permit
2. **PJ Pest Control Services** was **declared as passed**, subject to further evaluation;

**WHEREAS**, on **30 January 2025**, the Technical Working Group (TWG), evaluated the eligibility requirements of **PJ Pest Control Services** and found the following:

1. Submitted a quote of twenty-eight thousand pesos (PhP28,000.00) which is well within the Approved Budget for the Contract (ABC).
2. Submitted the necessary certificates approved by the Food and Drug Administration (FDA) and the Safety Data Sheet of chemicals. Based on the bidder's PhilGEPs account, the List of Eligibility document (Mayor's Permit) is outdated, but the bidder has submitted an updated copy of the Mayor's Permit.
3. The TWG observed that the bidder submitted three variants or pest control solution.
4. The TWG sent an inquiry to PJ Pest Control Services through BAC Secretariat with regards to the usage of the three chemical solutions.

5. The response from PJ Pest Control Services regarding the usage of the three chemicals was that the three products will be used in different areas separately and not mixed together.

**NOW, THEREFORE**, on motion duly made and seconded, the **BAC HEREBY RESOLVES** to:

1. Declare **PJ PEST CONTROL SERVICES** as the bidder with a **Single Calculated and Responsive Quotation (SCRQ)** and recommend the award of contract to the Head of the Procuring Entity (HoPE) for the "Provision of Pest Control Services for PTV Cordillera Station", RFQ No. 2024-064 in the amount of twenty-eight thousand pesos (PhP 28,000.00) inclusive of taxes, duties and other levies.
2. Instruct the BAC Secretariat to prepare all necessary documents needed for the completion of the procurement process.


