



BAC RESOLUTION NO. 2025-23
RECOMMENDING THE AWARD OF CONTRACT FOR RFQ NO. 2025-011 TO
EGM SYSTEMS GLOBAL TECHNOLOGIES, INC.

WHEREAS, the Administrative Division-Buildings & Grounds requested for “Supply, Delivery, Installation, and Configuration of Two (2) Units Power Modules for the Existing Uninterruptible Power Supply (UPS) at Technical Operation Center (TOC)”, with an Approved Budget for Contract (ABC) of nine hundred ninety-nine thousand nine hundred ninety-five pesos & 50/100 (PhP 999,995.50), as certified by the BAC Secretariat based on the inclusion in APP 2025 G-63 as of date of request;

WHEREAS, on 08 April 2025, the Secretariat of BAC-1 forwarded the said procurement request to BAC-2 for processing;

WHEREAS, on 14 April 2025, the previous BAC-2¹ chaired by Ms. Jasmine B. Barrios reviewed the said procurement request through Pre-Procurement Conference to check its readiness for posting;

WHEREAS, on 21 April 2025 the People’s Television Network, Inc., through its BAC-2, duly advertised the Request for Quotation (RFQ) for the aforementioned procurement under Small Value Procurement, RFQ No. 2025-011, by posting on the Philippine Government Electronic Procurement Service (PhilGEPS) and the Network’s official website;

WHEREAS, on 30 April 2025, during the opening of the quotation, the secretariat received the sealed bid from the sole bidder, namely **EGM Systems Global Technologies Inc.**;

WHEREAS, on the same date, the Bids and Awards Committee (BAC) conducted a preliminary review of the submitted quotation or proposal from the sole bidder and declared it as “Passed,” subject to further evaluation;

WHEREAS, on **8 May 2025**, BAC-2 has been reconstituted through Office Order No. 59 series of 2025 entitled "*Strengthening and Reconstituting the Bids and Awards Committee of the People's Television Network, Inc. (PTNI)*" chaired by Ms. Maria Raquel Apasan;

WHEREAS, on **20 May 2025**, the newly reconstituted BAC-2 convened and reviewed the evaluation of the TWG under the previous BAC-2 with the following findings and observations and instructed the TWG to re-evaluate the quotation;

1. Submitted a quote of **nine hundred ninety-three thousand two hundred pesos (Php993,200.00)** which is well within the Approved Budget for the Contract (ABC).
2. Submitted a duly signed conformity with the technical specifications, and eligibility requirements.
3. Submitted a product data sheet indicating the following:

WHEREAS, on **27 May 2025**, the newly reconstituted TWG presented the evaluation to the Committee with the following findings and observations:

1. Submitted a BIR Form No. 1702-RT with the attached eFPS Filing Reference No. 462400059191557, and indicated tax period is December 31, 2023.
2. The offered product has an input voltage of 400V, 3-phase, and an output voltage range of 230V - 400V, 3-phase. It supports an input frequency of 40-70 Hz and an output frequency of 50/60 Hz \pm 3 Hz user adjustable \pm 0.1 sync to mains 50 Hz \pm 0.1% for 50 Hz nominal not synced.
3. The bid is within the approved budget and accurately calculated.

WHEREAS, during the presentation, the Committee instructed the following:

1. Verify the BIR Form No. 1702-RT filing with Electronic Payment confirmation.
2. Request a written justification from the end-user for the concern on voltage.

WHEREAS, on **13 June 2025**, the BIR Form No. 1702-RT filing with Electronic Payment confirmation and written justification from the end-user were presented to the Committee and instructed the TWG to incorporate the documents into a written report;

WHEREAS, on **19 June 2025**, the TWG presented the written report with the following observation and findings:

1. Confirmed that the updated BIR Form 1702-RT, filed on 30 April 2025 is valid and compliant
2. The offered product specifications differ from the original requirements, the certification from the end-user dated June 2, 2025 justifies that the equipment is fit for its intended use and acceptable to the end-user

WHEREAS, on **24 June 2025**, the BAC-2 has been reconstituted through Office Order No. 75 series of 2025 titled "*Strengthening and Reconstituting the Bids and Awards Committee of the People's Television Network, Inc. (PTNI)*" chaired by Ms. Regina Celestre;

WHEREAS, on **26 June 2025**, the newly reconstituted BAC-2 convened for the transition of the ongoing projects under the previous BAC-2 including this procurement request where the newly reconstituted BAC requested to the end-user a detailed justification of accepting the specification of the offered product of the bidder;

WHEREAS, on **01 July 2025**, the end-user submitted a justification, as requested by the present BAC-2, for the acceptance of the offer and the technical specifications of the goods provided by EGM Systems Global Technologies Inc. In this justification, the end-user explained that the offered goods meet the functional and technical requirements based on the following considerations:

- The output voltage specification of 230V / 400V, 3-phase, indicated in the product data sheet, refers to the power module's main output configuration. In electrical terms:
 1. 230V represents the line-to-neutral voltage.
 2. 400V represents the line-to-line voltage
- This configuration aligns with standard 3-phase power systems and falls within the specified range of 380V to 415V, thereby meeting the end-user's required output voltage.
- Additional product documentation indicates that the power module's nominal output voltage can be configured to 380V, 400V, or 415V, 3-phase further confirming its compliance.
- The power module also features automatic detection and adjustment to the configuration of the existing UPS system upon installation, ensuring seamless compatibility and integration.

- The input frequency range of 40–70Hz and the output frequency of 50/60Hz meet the operational flexibility required by the UPS setup, which operates at 60Hz.
- The power module offered by EGM Systems Global Technologies Inc. is compatible with, capable of operating effectively, and operationally suitable for the existing UPS system. Furthermore, it meets and exceeds the minimum technical specifications required by the end user;

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee-2 (BAC-2), hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. Declare **EGM SYSTEMS GLOBAL TECHNOLOGIES, INC.** as the bidder with the **Single Calculated and Responsive Quotation (SCRQ)** based on the evaluation of previous TWG and the justification submitted by the end-user where the offered power module is compatible, effective and operationally suitable with the existing UPS system and exceeds the minimum technical specifications
2. Recommend the award of contract to the Head of the Procuring Entity (HoPE) for the **"Supply, Delivery, Installation, and Configuration of Two (2) Units Power Modules for the Existing Uninterruptible Power Supply (UPS) at Technical Operation Center (TOC)"**, RFQ No. 2025-011 in the amount of **nine hundred ninety-three thousand two hundred pesos (PhP 993,200.00)** inclusive of taxes, duties and other levies.
3. Instruct the Secretariat to prepare all necessary documents needed for the completion of the procurement process.
4. Notify all parties involved in the procurement process, on the result of the proceedings
