



BAC RESOLUTION NO. 2026-003
DECLARATION OF FAILURE OF BIDDING FOR THE CONTRACT OF
PROVISION OF SECURITY SERVICES FOR PEOPLE'S TELEVISION NETWORK,
INC AND ITS PROVINCIAL STATIONS, ITB NO. 2026-001

WHEREAS, Administrative Division - General Services requested for the “**Provision of Security Services for the People’s Television Network, Inc. and its Provincial Stations**” with an Approved Budget for the Contract of **thirty one million six hundred thirty-two thousand four hundred eight pesos (PhP 31,632,408.00)** which was reviewed by the Bids and Awards Committee (BAC) through a pre-procurement conference to confirm its readiness for the procurement;

WHEREAS, on 04 March 2026, the People’s Television Network, Inc. (PTNI), through its BAC, advertised the invitation to bid of the said request through **Competitive Bidding** under **ITB No. 2026-001** by posting in the Modernized Philippine Government Electronic Procurement Service (MPhilGEPS), the Network’s website and in conspicuous places within the network’s premises in accordance with the rules provided under Republic Act (R.A.) 12009 and its Implementing Rules and Regulations (IRR);

WHEREAS, on 11 March 2026, the pre-bid conference was held at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, in response to the said advertisement, only one (1) bidder purchased the bidding documents namely, **168 Security Agency Inc.;**

WHEREAS, on 23 March 2026, at 10:00 am, the deadline of bid submission, the secretariat received **one (1) bid** from **168 Security Agency Inc.** and **on the same day at 10:30 am,** the BAC conducted a preliminary examination of the submitted bids at the BAC Secretariat Office, 3rd Floor, Broadcast Complex, Visayas Ave., Diliman Quezon City and through video conferencing via Google Meet;

WHEREAS, during the conduct of the examination, the Bids and Awards Committee (BAC) found that, based on the submitted legal documents, particularly Annex “A” of the PhilGEPS Certificate, the Mayor’s Permit and Tax Clearance of 168 Security Agency, Inc. had already expired;

WHEREAS, pursuant to Section 52.1 of Republic Act No.12009 and its Implementing Rules and Regulations, for purposes of determining the eligibility of bidders

using the criteria stated in Section 52.4 of this IRR, the prospective bidder shall submit its **valid and updated** PhilGEPS Certificate of Registration (Platinum Membership) pursuant to the requirements provided in Section 20 of this IRR.

WHEREAS, Section 20.2.9.1 of the IRR states that all manufacturers, suppliers, distributors, contractors, consultants, and service providers shall upload and maintain in PhilGEPS a valid and updated file of the required eligibility documents, including: (a) registration certificates from the appropriate government agency; (b) updated General Information Sheet for corporations; (c) a valid Mayor's or Business Permit or its equivalent; (d) a valid Tax Clearance duly approved by the Bureau of Internal Revenue (BIR); (e) Philippine Contractors Accreditation Board (PCAB) License and Registration, where applicable; and (f) audited financial statements duly received by the BIR or its authorized institutions;

WHEREAS, after the conduct of an executive session, the BAC verbally notified the bidder that its bid was declared non-responsive for failure to comply with the required legal eligibility documents, and advised the bidder that, pursuant to Section 83.1 of RA 12009 and its IRR, it may file a request for reconsideration with the BAC within three (3) calendar days upon receipt of written notice or upon verbal notification of the BAC decision. The BAC shall decide on the request for reconsideration within seven (7) calendar days from receipt thereof. The bidder shall not be allowed to submit additional documents to correct any defects in the bid submitted;

WHEREAS, the BAC did not receive a request for reconsideration from **168 Security Agency, Inc.** within the prescribed period.

NOW, THEREFORE, for and in consideration of the foregoing, **WE**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to:

1. **DECLARE** the failure of bidding pursuant to Section 64 of Republic Act No. 12009 and its Implementing Rules and Regulations.
2. **CONDUCT** mandatory review of the project requirements, approved budget for the contract, and other necessary documents in accordance with RA 12009 and its IRR.
3. **DIRECT** the Secretariat to republish the project after the mandatory review and its inclusion in the FY2026 APP
4. **IMMEDIATELY NOTIFY** all concerned parties involved in the procurement process on the result of the bidding upon approval of this resolution.


