No.	Queries	Response
1	Is the administrative fee strictly required to be 20%? If a proposal indicates less than 20%, will it be automatically disqualified?	Yes, pursuant to Section 9 of RA 11917, the minimum administrative fee shall not be less than twenty percent (20%) of the total contract cost.
2	Will the deployment of security personnel in NCR and the provincial stations be implemented simultaneously within fifteen (15) calendar days from receipt of the Notice to Proceed (NTP), instead of on a phased basis?	Yes.
3	Should the security plan be conducted before or after personnel deployment, and will the requirement of ten (10) days after the actual deployment in each site still apply?	As stated in Annex B, Minimum Duties and Responsibilities of the Security Agency and Security Guards, under the responsibilities of the Agency, Item No. 13: "The AGENCY shall submit a Security Plan ten (10) days after the actual deployment at each site."
4	Is the site visit conducted after the winning bidder has been identified?	Yes.
5	Are there any required attachments for the statement of all ongoing government and private contracts?	No, there are no required attachments for the Statement of All Ongoing Government and Private Contracts. For guidance, a sample form is attached in the Bid Bulletin as Annex A. Kindly refer to the instructions indicated therein.
6	Do we need to strictly follow the envelope color coding based on the provided visual representation?	Any envelope color may be used.

All other information in the Bidding Documents inconsistent with the above is hereby revised accordingly. All other provisions which are not affected shall remain in effect.
